Der blev fremsat indsigelse mod endelig registrering af varemærket MP 1186526 AYONA <fig> for nogle af de ansøgte varer og tjenesteydelser. Indsigelsen blev begrundet med, at det foreløbigt registrerede mærke MP 1186526 AYONA <fig> er forveksleligt med indsigers ældre varemærker VR 1990 07246 ROLEX DAYTONA <fig> samt indsigers EU-varemærkeregistrering nr. 001457639 DAYTONA. Patent- og Varemærkestyrelsen tog ikke indsigelsen til følge og opretholdt registreringen i sin helhed. Denne afgørelse blev indbragt for Ankenævnet for Patenter og Varemærker, som stadfæstede den påklagede afgørelse.

Ankenævnet har behandlet sagen skriftligt.

Ankenævnet udtales:

Ankenævnet for Patenter og Varemærker lægger som Patent- og Varemærkestyrelsen til grund, at der foreligger varesammenfald inden for visse klasser, at både ROLEX og DAYTONA har bevaret deres

selvstændige adskillelsesevne, at der derfor kan lægges selvstændig vægt på ordelementet DAYTONA i indsigers mærke ROLEX DAYTONA og at både AYONA og DAYTONA udgør to særprægede ord.

Ankenævnet kan dernæst tiltræde styrelsens vurdering af, at hverken den visuelle, den lydlige eller den begrebsmæssige lighed mellem DAYTONA og AYONA er tilstrækkelig til, at der samlet foreligger en risiko for forveksling.

Ankenævnet finder endelig, at ligheden ikke, selv hvis man lagde til grund, at DAYTONA måtte anses for at være velkendt her i landet, ville være tilstrækkelig til at skabe en sådan sammenhæng mellem de to mærker som krævet i henhold til EU-Domstolens afgørelse i Sag C-408/01, Adidas/Fitnessworld.

Herefter bestemmes:

Den påklagede afgørelse stadfæstes.

klasse 37 og 41, og indsigers danske varemærkeregistrering VR 1990 07246 , som er registreret for varer i klasse 14, samt indsigers EU-varemærkeregistrering nr. 001457639 DAYTONA, som er registreret for varer i klasse 09 og 14, samt tjenesteydelser i klasse 37. Indsiger anførte, at der foreligger fuld varekollision mellem indehavers angrebne mærke og indsigers mærker for så vidt angår klasse 14, samt at der foreligger høj grad af varelighed for så vidt angår klasse 09, 37 og 41. Indsiger anførte, at ordelementet i indehavers angrebne mærke AYONA ligger meget tæt op ad ordelementet DAYTONA i indsigers mærker. Indsiger understregede, at begge ordelementer består af tre stavelser, hvori vokalerne er identiske. Det er derfor kun D og T, som er det første og fjerde bogstav i DAYTONA, der adskiller sig fra AYONA. Indsiger henviste ligeledes til en række OHIM afgørelser. I sletningssag nr. 7478 C, vurderede OHIM, at figurmærkerne SOLIGNO og LIGNO var forvekslelige. Ligeledes vurderede OHIM i indsigelsessag B 2 117 706 CITIZEN og CTZEN forvekslelige. Desuden vurderede OHIM i ankesag R 1660/2011-4 ONASSIS og OASIS forvekslelige. Indsiger nedlagde påstand om, at mærket DAYTONA er velkendt i Danmark og vedlagt dokumentation herfor. Indsiger anførte, at en tilsvarende indsigelse er nedlagt i en række andre lande, og anmoder om, at indehavers angrebne mærke afvises fra endelig registrering for følgende varer og tjenesteydelser:

Ud fra vurderingen af det indsendte materiale, er det styrelsens vurdering, at DAYTONA har en vis grad af velkendthed i den relevante omsætningskreds på det danske marked for ”ure”. Styrelsen har i denne vurdering især lagt vægt på at DAYTONA er brugt som et varemærke i reklamer og annoncer fra Magasinet BUSINESS, som er et tillæg til Berlingske Tidende, BØRSEN WEEKEND, dettes tillægsmagasin PLEASURE, samt artiklen i EUROMAN, som er landsdækkende aviser og magasiner, og derfor distribueres i stort opplag til hele landet. Ligeledes har styrelsen lagt vægt på fakturaer udstedt til danske forhandlere, som f.eks. KLARLUND A/S, som viser, at DAYTONA ure er bestilt til forhandlere i København, Århus, Herning og Odense i perioden 2009-2013. Dog kan en bestanddel af et sammensat varemærke i den konkrete situation bevare en selvstændig adskillelselevne uden ellers at udgøre mærkets dominerende bestanddel. Dette følger af EU domstolsafgørelsen C-120/04 THOMSON LIFE. Da både ROLEX og DAYTONA har opnået en vis grad af velkendthed på det danske marked, er det styrelsens vurdering, at ordelementerne ROLEX og DAYTONA i denne konkrete situation bevarer deres selvstændige

adskillelsesevne, hvorfor der i lighedsvurderingen kan lægges mere vægt på elementet DAYTONA i indsigers mærke ROLEX DAYTONA.

Både DAYTONA og AYONA er to særprægede ord, og det er derfor ordelementerne, der er de dominerende mærkeelementer.

a) Den visuelle lighed mellem DAYTONA og AYONA

Selvom indehavers angrebne mærke er fuldstændigt indeholdt i indsigers mærker, er der kun en meget lille visuel lighed mellem mærkerne. Det er kun sidste stavelse NA i mærkerne, der er identiske, mens der er stor forskel på første stavelse, som i indehavers angrebne mærke kun er på et bogstav A og indsigers mærkers første stavelse er på tre bogstaver DAY. Indehavers anden stavelse er på to bogstaver YO, og selvom indsigers anden stavelse også er på to bogstaver, er det kun det sidste bogstav, der er ens, nemlig O, mens Y og T er forskellige.

b) Den lydlige lighed DAYTONA og AYONA

Selvom indehavers angrebne mærke er fuldstændigt indeholdt i indsigers mærker er der kun en meget lille lydlig lighed mellem mærkerne. Selvom vokalerne i begge mærker har samme rækkefølge, er det kun sidste stavelse NA i mærkerne, der udtales identisk, mens Indsigers to første stavelser starter med henholdsvis D og T, som udtales hårdt, udtales indehavers mærke blødt, da de to første stavelser blødt, da de begge starter med vokaler.

c) Den begrebsmæssige lighed DAYTONA og AYONA

Der er ikke nogen begrebsmæssig lighed mellem mærkerne. AYONA er et særpræget kunstord, som ikke giver nogen klare associationer, mens DAYTONA er en geografisk betegnelse for f.eks. en strand i Florida, hvor der afholdes forskellige racerløb. Der er derfor ikke nogen klar begrebsmæssig lighed mellem eller forskel på mærkerne.

Konklusion vedrørende vurderingen af risikoen for forveksling

Da der kun er en meget lille visuel og lydlig lighed, og der ikke er nogen begrebsmæssig lighed mellem mærkerne, er det styrelsens vurdering, at der ikke foreligger risiko for forveksling.

5. Vurdering af utilbørlig udnyttelse af det ældre mærke efter § 15, stk. 4, nr. 1, og § 15, stk. 3, nr. 1

Anvendelsen af bestemmelserne i varemærkelovens § 15, stk. 4, nr. 1 og § 15, stk. 3, nr. 1, forudsætter,

- at det ældre varemærke er velkendt i den relevante omsætningskreds,
- at der i den relevante omsætningskreds' bevidsthed skabes en sammenhæng eller association mellem mærkerne, og
- at brugen af det yngre mærke – uden skellig grund – vil medføre en utilbørlig udnyttelse af eller skade på det velkendte varemærkes særpræg eller renommé.

Efter styrelsens og Ankenævnet for Patentet og Varemærkers praksis indebærer disse krav bl.a., at en sammenhæng eller association mellem et yngre dansk registreret mærke og et ældre varemærke alene kan anses for at være opstået som følge af den til det ældre varemærke knyttede velkendthed, såfremt varemærket er velkendt i den danske omsætningskreds., jf. bl.a. AN 2011 00002.

Indledningsvist skal bemærkes, at mærkerne begge er registrerede for ”ure” i klasse 14, hvilket er den vare, som indsigers mærker har opnået en vis grad af velkendthed for i Danmark.

I vurderingen af, om et yngre mærke skaber associationer til et ældre, velkendt varemærke skal indgå alle relevante faktorer, herunder ligheden mellem mærkerne, ligheden mellem varerne, mærkernes særpræg og den grad med hvilken det ældre mærke er velkendt.

Selvom mærkerne indeholder de samme vokaler og har en konsonant til fælles, er det styrelsens vurdering, at mærkerne er så forskellige, at den relevante omsætningskreds, som ser indehavers angrebne mærke ikke vil drage associationer til indsigers velkendte mærke. Allerede af denne grund, kan det konkluderes, at der ikke kan foreligge utilbørlig udnyttelse af skade på det ældre velkendte mærkes særpæg eller renommé.

6. Vurdering og konklusion

Ved vurderingen af forvekslelighed er der særligt lagt vægt på, at der er tale om særprægede ordelementer, som både visuelt og lydligt har en meget lille grad af lighed, samt at der ikke foreligger nogen begrebsmæssig lighed.

Selvom der er sammenfald mellem varerne i klasse 09 og 14, samt tjenesteydelserne i klasse 37 i indehavers angrebne mærke og indsigers mærker, foreligger der ikke nogen risiko for forveksling, fordi der ikke er tilstrækkelig lighed mellem mærkerne.

DAYTONA er til en vis grad et velkendt mærke for ure på det danske marked. Ved vurderingen af, om AYONA krænker det velkendte mærke, er der lagt vægt på, at AYONA ikke giver associationer til DAYTONA, og at kravene efter § 15, stk. 4, nr. 1 og § 14, stk. 3, nr. 1 allerede af denne grund ikke er opfyldt.

Vi tager derfor ikke indsigelsen til følge, og registreringen er fortsat gyldig i Danmark.

Vi har afgjort sagen efter varemærkelovens § 15, stk. 1, nr. 2 og § 15, stk. 4, nr. 1 jf. § 4, stk. 2 og § 15, stk. 3, nr. 1..."

Denne afgørelse blev med brev af 24. november 2015 fra Budde Schou A/S på vegne klager, ROLEX SA, indbragt for Ankenævnet for Patenter og Varemærker med følgende påstand:

På vegne af vores klient, ROLEX SA, Geneve, Schweiz, påklages herved Patent- og Varemærkestyrelsens afgørelse af 22. september 2015, reference MP 1186526, vedrørende registrering af figurmærket AYONA for en bred varefortegnelse i klasserne 05, 09, 14, 16, 18, 20, 21, 24, 25, 28, 35, 36, 37, 38, 39, 41, 42, 43, 44 og 45.

Påstand:

Styrelsens afgørelse af 22. september 2015 omgøres, og den danske del af det internationale varemærke MP1186526 AYONA afvises fra endelig registrering, for så vidt angår nedenstående varer og tjenesteydelser:

- Class 09: time recording apparatus, time switches, egg timers [sandglasses], chronographs [time recording apparatus], time clocks [time recording devices];
- Class 14: Agates; diamonds; amulets [jewellery, jewelry (am.)]; anchors [clock and watch making]; barrels [clock and watch making]; bracelets [jewellery, jewelry (am.)]; straps for wristwatches; charms [jewellery, jewelry (am.)]; key rings [trinkets or fobs]; brooches [jewellery, jewelry (am.)]; alarm clocks; pins [jewellery, jewelry (am.)]; ornamental pins; tie pins; beads for making jewelry; pearls made of ambroid [pressed amber]; busts of

precious metal; jet, unwrought or semi-wrought; pearls [jewellery, jewelry (am.)]; copper tokens; tie clips; cuff links; badges of precious metal; gold, unwrought or beaten; cloisonné jewellery [jewelry (am.)]; ivory [jewellery, jewelry (am.)]; works of art of precious metal; jewellery; jewellery of yellow amber; iridium; precious stones; semi-precious stones; spun silver [silver wire]; necklaces [jewellery, jewelry (am.)]; rings [jewellery, jewelry (am.)]; boxes of precious metal; watch cases; clock cases; pendulums [clock and watch making]; medals; lockets [jewellery, jewelry (am.)]; precious metals, unwrought or semi-wrought; movements for clocks and watches; clockworks; coins; gold thread [jewellery, jewelry (am.)]; threads of precious metal [jewellery, jewelry (am.)]; silver thread; olivine [gems]; osmium; palladium; platinum [metal]; chronometrical instruments; watch springs; rhodium; ruthenium; stopwatches; silver, unwrought or beaten; earrings; ingots of precious metals; alloys of precious metal; statues of precious metal; statuettes of precious metal; watch crystals; paste jewellery [costume jewelry (am.)]; clock hands [clock and watch making]; ornaments [jewellery, jewelry (am.)]; shoe ornaments of precious metal; hat ornaments of precious metal; ornaments of jet; cases for watches [presentation]; cases for clock- and watchmaking; chronographs [watches]; chronometers; chronoscopes; chains [jewellery, jewelry (am.)]; watch chains; dials [clock and watch making]; atomic clocks; watches; sundials; clocks and watches, electric; control clocks [master clocks]; clocks; wristwatches; jewellery cases [caskets]; spinel [precious stones].

Velkendthed.

På baggrund af en meget omfattende dokumentation anmoder vi om, at mærkets velkendthed bliver lagt til grund i den fortsatte behandling.

Vare-/tjenesteydelseskollision

Klasse 9: Styrelsen fastslår, at der er vareidentitet for de i indsigelsen anførte varer, hvilket vi selvfølgelig tilslutter os.

Klasse 14: Styrelsen fastslår, at der er vareidentitet for mange af de anførte varer samt varelighed for stort set alle de andre anførte varer. Vi tilslutter os selvfølgelig dette, men skal påpege, at vi stadig fastholder, at termen ”control clocks [master clocks]” er identisk eller forvekslelig med vores klients registrerede rettigheder, hvilket ikke fremgår af Styrelsens afgørelse. Vi henviser endvidere til, at termen ”watch straps” indgår som et overbegreb i vores klients CTM registrering i klasse 14, og er derved identisk med indehaverens ansøgte term ”straps for wristwatches” i klasse 14, hvilket fremstår modsat i Styrelsens afgørelse.

Klasse 37: Styrelsen påpeger, at der er identitet mellem de af indehavers anførte ydelser og indsigers ydelser, hvilket vi selvfølgelig tilslutter os.

Klasse 41: Styrelsen anfører, at der ikke foreligger sammenfald eller ligeartethed mellem indehavers ydelse ”timing of sports events” og vores klients registrerede rettigheder til forskellige tidtagningsapparater i klasse 9, alene på den baggrund, at der som udgangspunkt ikke er lighed mellem varer og tjenesteydelser. Det er korrekt, at der som udgangspunkt ikke er lighed mellem varer og tjenesteydelser, men man skal i vurderingen heraf inddrage de konkrete salgs- og distributions forhold, hvorved det er svært at se, at der ikke er en lighed mellem den genstand/vare, som man anvender til at tage tid til et sportsarrangement og den ydelse, som man tilbyder ved tidtagning til et sports event. Vi henviser endvidere til VML-Bet. side 110, hvor det nævnes som eksempel på ligeartethed mellem varer og tjenesteydelser, at der er ligartethed mellem varerne vaskemidler og vaskemaskiner over for tjenesteydelser der udbydes af et vaskeri altså en lighed mellem den ydelse, som man udbyder og de genstande/varer, som man anvender til at udbyde ydelsen.

På baggrund af ovenstående og vores første argumentation over for Styrelsen, fastholder vi, at der er varekollision mellem alle de i indsigelsen anførte varer og tjenesteydelser og vores klients registrerede rettigheder.

Mærkelighed

Styrelsen anfører, at der kun er en meget lille visuel lighed mellem mærkerne selvom AYONA er fuldt indeholdt i DAYTONA.

Styrelsen anfører, at det kun er den sidste stavelse NA, der er visuelt identisk, hvilket vi bestrider. Bortset fra det indledende D, så er det visuelt kun et T, der adskiller AYONA fra at være direkte tilstede i vores klients mærke **DAYTONA**, hvilke giver en klar visuel lighed mellem mærkerne. I indsigelsesafgørelsen anfører Styrelsen, at der kun er en lille lydmæssige lighed mellem mærkerne, vi vil dog fastholde at den lydmæssig lighed mellem mærkerne er markant.

Udtalen af den første stavelse af indehavers mærke "A" vil blive påvirket af den næste stavelses begyndelse, og vil derfor komme til at lyde som AY, hvilket er lydmæssigt lignende den første stavelse i vores klients mærke DAY. Endvidere er det ikke kun den sidste stavelse NA, som er identiske, men hele lyden ONA, som giver en karakteristisk lydmæssig endelse på begge mærker. På baggrund af ovenstående samt at AYONA er fuldt indeholdt i DAYTONA, og at vokalerne har samme rækkefølge i begge mærker, vil vi fastholde, at mærkerne har en stor lydmæssig lighed.

Forvekslighed

Der foreligger både vareidentitet samt varelighed for de anførte varer samt en høj grad af visuel og lydmæssighed lighed mellem vores klients mærker DAYTONA og indehavers mærke AYONA.

Derfor må man ud fra en helhedsbedømmelse vurderer, at der er en høj grad af risiko for forveksling.

Vi kan udover ovenstående argumentation bekræfte, at vores klients indsigtelser mod indehavers mærke i nedenstående lande er blevet afgjort til fordel for vores klient. Se vedhæftede bilag (1-13).

Tyskland (bilag 1), Litauen (bilag 2), Irland (bilag 3), Kroatien (bilag 4), Storbritannien (bilag 5), Bulgarien (bilag 6), Cypern (bilag 7), Ungarn (bilag 8), Benelux (bilag 9), Australien (bilag 10), Østrig (bilag 11), Ukraine (bilag 12) og Frankrig (bilag 13).

Vi hæfter os herunder særligt ved den franske afgørelse hvor der jf. begrundelsen for mærkernes forvekslelighed er lagt til grund:

Om sammenligning af tegnene:

Eftersom det omstridte mærke bærer benævnelsen AYONA gengivet herunder:

AYTONA

Eftersom det ældre påberåbte mærke bærer benævnelsen DAYTONA gengivet herunder:

DAYTONA

Eftersom indsigtervirksomheden gør gældende, at det omstridte tegn efterligner det ældre mærke.

Eftersom efterligningen medfører påvisningen af en risiko for forveksling mellem tegnene, som således skal vurderes samlet set ud fra alle faktorer, der er vedkommende for sagen; at denne samlede vurdering bør, hvad angår den visuelle, auditive eller begrebsmæssige lighed mellem de pågældende mærker, være begrundet med det samlede indtryk mærkerne giver, idet især deres særprægede og dominerende elementer tages i betragtning.

Eftersom visuelt set den omstridte benævnelse AYONA og den påberåbte benævnelse DAYTONA har en sammenlignelig længde (henholdsvis 5 og 7 bogstaver) og har 5 bogstaver til fælles (A, Y, O, N og A) placeret i samme rækkefølge og udgørende ens sekvenser AY- og -ONA, hvilket bibringer dem et meget ens udseende;

Eftersom det omstridte tegns særlige skriftype forekommer ubetydelig og ikke kan opfattes;

Eftersom tegnene fonetisk set udtales i tre stavelsesformer og de på hinanden følgende lyde ligner hinanden meget [èi-o-na] eller [aü-o-na] for det omstridte tegn og [dèi-o-na] for det ældre mærke.

Eftersom det følger af det foregående, at de to tegn har en meget ens visuel og fonetisk benævnelse til fælles, således at forbrugerne kan forveksle (AYONA / DAYTONA);

Eftersom indsigtervirksomheden desuden gør gældende, at det ældre mærke nyder et vist renommé inden for urmageri, og dette renommé kommer til at forstærke risikoen for forveksling med det omstridte tegn.

Eftersom det omstridte tegn således udgør en efterligning af de påberåbte ældre mærke.

Eftersom der samlet set eksisterer en risiko for forveksling i offentlighedens bevidsthed vedrørende mærkernes oprindelse på grund af identiteten og ligheden mellem visse af de pågældende varer og det omstridte tegns efterligning af det ældre mærke.

Eftersom benævnelsen AYONA som følge heraf ikke kan opnå beskyttelse i Frankrig som varemærke for identiske og lignende produkter uden at skade indsigtvirksomhedens tidligere rettigheder til benævnelsen DAYTONA.

Konklusion

Vores klients mærker velkendthed i Danmark og nyder derfor en udvidet beskyttelse for utilbørlig udnyttelse af deres særpræg og renommé jf. Varemærkelovens § 15, stk. 3, nr. 1 og § 15, stk. 4, nr. 1. Styrelsen anfører selv i deres afgørelse de betingelser, der skal være opfyldt for at ovennævnte paragraffer kan tages i anvendelse. Vi vil på baggrund af den første korrespondance i indsigsessagen samt nærværende anke fastholde, at ovennævnte betingelser er opfyldt, og at bestemmelserne derfor bør anvendes.

Idet der både foreligger varelighed og vareidentitet, må der ud fra en helhedsbetragtning tages hensyn hertil i bedømmelsen af mærkelighed. Idet indehaverens mærke er fuldt indeholdt i vores klients registrerede mærker sammenholdt med mærkernes visuelle og lydmæssige lighed og den udvidede beskyttelse af et velkendt mærke, må det antages, at der er en stor risiko for forveksling mellem mærkerne.

På baggrund af ovenstående og den hidtil første argumentation og dokumentation i indsigsessagen anmoder vi hermed Klagenævnet for Patenter- og Varemærker om at omgøre Styrelsens afgørelse af 22. september 2015, og afvise den danske del af det internationale varemærke MP1186526 AYONA fra endelig registrering, for så vidt angår ovennævnte varer og tjenesteydelser...”

Med brev af 19. februar 2016 afgav Patent- og Varemærkestyrelsen følgende udtalelse:

”... Som svar på Ankenævnets brev af 28. januar 2016 skal styrelsen udtale følgende:

Under behandlingen for Ankenævnet ses der ikke at være fremlagt sådanne nye væsentlige argumenter, at styrelsen har anledning til at ændre opfattelse.

Styrelsen fastholder derfor afgørelsen af 22. september 2015 og den under behandlingen fremførte argumentation og vurdering.

Styrelsen skal således henstille til Ankenævnet, at den trufne afgørelse stadfæstes...”

Med brev af 21. marts 2016 kommenterede Budde Schou A/S på vegne klager, ROLEX SA, styrelsens udtalelse således:

”... På baggrund af Patent- og Varemærkestyrelsens høringssvar henstilles det, at Ankenævnet tager den foreliggende sag op til objektiv vurdering af registrerbarheden af den danske del af IR 1186526 AYONA, særligt under hensyntagen til den i sagen fremlagte dokumentation for DAYTONA mærkets udbredelse og velkendthed i Danmark, samt den refererede praksis, der sammenholdt med vores argumentation bekræfter, at AYONA maretet bør anses som en utilbørlig udnyttelse af DAYTONA varemærkets særpræg og renommé jf. Varemærkelovens § 15, stk. 3, nr. 1.

Vores klient har bedt os meddele, at man ikke ønsker at anmode om en mundtlig forhandling i sagen...”

Indklagede har ikke udtalt sig i sagen.
